Driven and passionate, Jilan Hall-Johnson educated herself on every aspect of owning a small business when she moved to Billings with a dream of opening a restaurant. A culinary artist with a heart for serving others, she developed a solid plan and turned to the Billings SBDC to get assistance in opening her dream, The Sassy Biscuit Co.

Dena Johnson, Billings Regional Director, and the Billings SBDC team assisted Jilan with consulting, training and technical assistance to develop projections and fine tune her business plan. The assistance provided by the SBDC helped her become business-ready and enabled her to approach the bank with solid projections.

The Sassy Biscuit was able to successfully secure SBA financing for start-up costs as well as a grant from the Downtown Billings Alliance that helped with lease-hold improvements. In 2018, The Sassy Biscuit Co. opened their doors creating 10 jobs and an amazing place for the community to gather. The Sassy Biscuit Co. is already a growing hotspot as a unique business and Jilan has risen as a community leader and as an inspiration to other budding small business owners.

Core Control, Inc.

In 2018, Core Control, Inc. found itself in a transition period due to a change in leadership. The shift proved to be challenging, and the overall operating performance along with declining profitability became concerns. The new leadership team turned to Tom Walker, Regional Director at the Bozeman SBDC, for assistance.

Tom helped the Core Control senior team realign management oversight to allow for streamlined decision-making. The SBDC also helped Core Control analyze and reduce its expenses by creating a new management system.

Under the senior team and direct leadership of new General Manger Eric Bueling, Core Control quickly and successfully managed to work through a difficult management transition and cash flow shortfall by reducing expenses and refocusing sales efforts to a more profitable market segment. The results have been a 10 percent reduction in expenses, improved operating performance and the retention of all current employees.

A mechanical engineering graduate from Montana Tech, Brian Gollehon had dreams of making a mark on the oil and gas industry with the creation of technological systems and processes that would enhance efficiencies, minimize risk and increase revenue. He turned to the SBDC for help.

Julie Jaksha, Regional Director for the Butte SBDC, aided with financial projections and the initial plans to launch his business. Brian and Julie spent hours on his marketing plan as well as refining his pitch presentation to potential clients. The SBDC arranged for Brian to practice his pitch to a few statewide investors who were well versed in the oil industry. Through insight brought forth by the investors, Brian was able to focus his vision and began targeting high-impact clients, which resulted in test-site opportunities throughout the Bakken that propelled his business to the next level.

Accu-Scribe currently has operations in North Dakota, Texas, Colorado, Wyoming, California, Canada and eastern Europe and is in negotiations to deploy its technology across the world. Accu-Scribe has paved the way for the rig of the future that brings cutting-edge technology to an industry eager for ways to decrease costs of operations.

Pardue Grain, Inc.

After operating as a storage facility for six decades, Pardue Grain owners Lisa and Roger Sammons discovered an opportunity presented in business cases published by the SBDC host, the Great Falls Development Authority, that highlighted opportunities for pulse crop expansion within the Golden Triangle. The discovery inspired the Sammons to expand their business to include a pulse processing facility.

Jason Nitschke, Great Falls SBDC Regional Director, began work on the project in June 2017 to assist the Sammons with the financial feasibility, strategic planning, loan packaging, grant writing and team-building with additional resource partners. He referred the Sammons to the Montana Manufacturing Extension Center for assistance in designing the new facility and sourcing the equipment needed for the processing line. Jason continued to provide guidance for three loan applications, a USDA guarantee, three grant applications, marketing assistance, and ongoing project and business management support.

In the winter of 2018, Pardue Grain opened its state-of-the-art, 32,000-square-foot pulse processing facility after attracting more than \$7 million in investment from eight sources of funds. The expansion will significantly reduce transportation costs for Montana growers within the Golden Triangle and create an additional 20 high-wage jobs on the Blackfeet Reservation in Glacier County.

Ashley Weinheimer and Anthony Windy Boy dreamt of owning their own business and in 2018 that dream became a reality. When the owner of Boxcars, a local bar, decided to sell, Ashley and Anthony jumped at the chance. Having never owned their own business they turned to the Havre SBDC for assistance in completing the process of becoming business owners.

Joe LaPlante, Havre Regional Director, worked with Ashley and Anthony in developing a business plan backed by solid financial projections to assist with the lending process. He worked with them to identify funding solutions that best fit their needs and provided guidance on financial documents required by their lender.

With the support from the Havre SBDC Ashley and Anthony were able to secure financing to purchase the existing business, retaining two jobs and creating an additional four. They also repaired the iconic toy train that runs around the top of the restaurant. Boxcars is once again a reliable source of amazing food and quality customer service in downtown Havre.

Ristorante Bella Roma

Davide Giuliani was born and raised in Rome, Italy, and brought his formal training and his grandmother’s recipes to Montana in 2016. Starting with reservation-only pop-up restaurants in East Helena, David eventually opened Bella Roma, a traditional Italian restaurant, in leased space. After a year of operating four days a week in a space that provided seating for 30 customers, Davide turned to the Helena SBDC for assistance in finding a new location.

The Helena SBDC worked with Davide to measure the feasibility of moving to a new location by developing projections and revising his business plan. In addition, the Helena SBDC assisted Davide in finding a new location that would be suitable for his upscale restaurant.

With help from the Helena SBDC, Davide was successful in negotiating with the owner of the Doubletree by Hilton to renovate and lease the space that had been vacated by another restaurant. Bella Roma secured a bank loan of \$25,000 to assist in the renovations. The new location allows customers to have an outdoor dining experience while increasing indoor seating accommodations from 30 customers to 70. Bella Roma is now open seven days a week, has created seven new jobs and has increased overall sales.

Montana Hoof Care

Marion Eash and his wife Sara started Montana Hoof Care in 2008 after moving to Fortine, Montana. Marion has been a farrier for 17 years and works beside his brother and the occasional part-time help. Marion and Sara needed an indoor space to add business lines complementary to the farrier business, especially in the winter months, and they turned to the Kalispell SBDC for assistance.

Dan Gorton, Kalispell Regional SBDC Director, did a commercial loan/financial analysis on Marion’s business to determine if building an indoor space was a viable option for him to pursue. Dan also did a break-even analysis and projected revenue from some alternative uses for the building to show the lenders that the multi-use facility would create other lines of business to allow for Montana Hoof Care’s growth.

Marion was able to obtain bank financing in the amount of \$250,000 with an additional owner investment of \$40,000. The addition of a 100’ x 200’ indoor arena will add one part-time employee upon completion. The construction of the indoor riding arena will allow Montana Hoof Care to offer boarding, horse clinics and related events in addition to being able to work inside during the winter months.

Driven Repair, LLC

Gregg Clark, owner of driven repair had been operating his diesel truck repair business from a leased facility since early 2016. In late 2017 he was approached with the opportunity to buy the building and property located outside of Miles City.

Gregg turned to the Miles City SBDC for assistance. The SBDC provided guidance on the business planning process, market research, financial projections, and loan packaging. With the assistance of the Miles City SBDC, the loan process was successfully accelerated allowing Driven Repair to receive the requested funding.

In 2018, Gregg was able to take advantage of the opportunity and finalize the purchase. The financing also allowed Gregg to fix drainage issues on the property and make general repairs to the building. Gregg has added a full-time mechanic that is well versed in both truck and agriculture equipment maintenance and repair. The improvement to the property along with the additional technician allows Driven Repair to meet the demand for diesel truck repair services in Miles City and the surrounding area.

Spartans Vehicle Repair & Tuning

Milt and Jennifer Itskos have a successful vehicle repair business in Missoula with an impeccable reputation. Spartans has such a good reputation that clients are often willing to wait for service rather than work with another vehicle repair business. The high demand was exceeding the human resources and physical capacity of the existing repair facility. Milt and Jennifer contacted the Missoula SBDC for assistance in scaling their business.

Jenn Stephens, Missoula Regional Director, assisted Milt and Jennifer with financial projections and business planning guidance for their initial plan to build a new vehicle repair shop. When Milt and Jennifer found an existing vehicle repair center that was for sale, Jenn helped identify SBA loans that they qualified for and assisted them through the lending process.

With the help from their local SBDC, Milt and Jennifer were successful in securing \$1,209,000 in total financing for the purchase of the existing facility. The new, larger location has allowed Spartans to retain four jobs and create an additional two. As of January 2019, revenues for Spartans are exceeding projections by 35% to 40%. Milt and Jennifer continue to grow their business by providing superior customer care and consistent vehicle repair services to their clients.

Wheatland Lodge

For 65 years, the Juel Motel located in Scobey, Montana, has offered accommodations to bird hunters, tourists and business travelers alike. The Juel family developed a tradition of success, and when it came time to sell, they sought new owners who could continue that tradition. In 2018, the Juel family approached Kent and Twyla Holum with the opportunity.

Kent, an experienced auto body technician, and Twyla, a part-time bookkeeper at an agricultural company, always had an interest in becoming business owners. When the opportunity arose, they turned to Shandy Hanks, SBDC Regional Director at the Wolf Point SBDC for assistance. Shandy provided guidance on the loan packaging process for gap financing at Great Northern Development Corporation.

With the help from Shandy, Kent and Twyla were successful in receiving \$25,000 in gap funding to leverage over \$200,000 in total financing for the purchase. The Holums were able to create one additional job while retaining the existing staff. The motel was renamed “The Wheatland Lodge” and continues to provide comfortable accommodations and the great service it has become known for.
